COMMISSION MEETING AGENDA

1. New Jersey Family Collaborative Law Act - Consideration of a revised Draft Tentative Report regarding the New Jersey Family Collaborative Law Act, which incorporates comments received since the November 5th Tentative Report, updates the Report, and makes further modifications to accommodate commenter concerns.
2. Tuition Aid Grants – Consideration of a proposed project recommending a modification of *N.J.S. 18A:71B-2* (Student eligibility) as a result of the Court's determination in *A.Z. ex rel. B.Z. v. Higher Educ. Student Assistance Authority*, 427 *N.J. Super.* 389 (App. Div. 2012).
3. Department of Correction Identification Card and License to Drive – Consideration of a proposed project recommending a modification of *N.J.S. 30:1B-6.2* to state that a former inmate's Department of Corrections identification card has a two-point value in applying for a non-driver identification card (current law) *and* for a license to drive in New Jersey (new).
4. Underground Facility Protection Act – Consideration of a proposed project recommending a modification of *N.J.S. 48:2-80(d)* as a result of the Court's determination in *Jersey Central Power & Light Co. v. Melcar Utility Co.*, 2013 WL 263107 (N.J. Jan. 24, 2013).
5. Recording Mortgage Servicers - Consideration of a Draft Tentative Report embodying a new approach on mortgage recording and avoiding the problems presented by commenters at the November meeting.
6. Uniform Principal and Income Act - Consideration of a Draft Final Report recommending the incorporation in the New Jersey statute (in *N.J.S. 3B:19B-17* and *N.J.S. 3B:19B-28*) of 2009 amendments to the Uniform Act.
