### **COMMISSION MEETING AGENDA**

1. Uniform Foreign-Country Money Judgments Recognition Act – Consideration of a Draft Final Report regarding this Act and recommending enactment of the recently-introduced bill A4163.
2. Uniform Act on Prevention of and Remedies for Human Trafficking – Consideration of a Draft Tentative Report proposing modifications to NJ law to more clearly delineate when a business entity could be held liable and to expand New Jersey's Human Trafficking law to expressly include forced sexually explicit performances.
3. Sales and Use Tax Act – Consideration of a Draft Tentative Report proposing modifications to address the lack of a definition of the term "bus" in response to the Court's determination in *Air Brook Limousine, Inc. v. Director, Division of Taxation*, 2012 WL 3166607 (App. Div. 2009), *certif. denied*, 213 N.J. 568, 65 A.3d 835 (2013).
4. Civil Unions – Consideration of a Memorandum proposing modification to the New Jersey civil union dissolution grounds to add irreconcilable differences, reflecting the Court's determination in *Groh v. Groh*, 2014 WL 7647544 (Ch. Div. 2014).
5. Unlawful Possession of Weapons (N.J.S. § 2C:39-5(i)) – Consideration of a Memorandum proposing modification to the statutory provision determined to be unconstitutional in *State v. Grate*, 2015 WL 176343 (N.J. Sup. Ct. Jan. 15, 2015).
6. Uniform Premarital and Marital Agreement Act – Consideration of a Memorandum recommending that the Act not be enacted in New Jersey in deference to New Jersey's existing body of law, including 2013 amendments to the relevant statute.
