COMMISSION MEETING AGENDA

1. Uniform Common Interest Ownership Act – Consideration of Draft Final Report and an explanatory Memorandum regarding the Uniform Common Interest Ownership Act.
2. Expungement – Consideration of a Revised Draft Tentative Report proposing changes to N.J.S. 2C:52-4.1(a) in response to the decision of the New Jersey Supreme Court, *In re D.J.B.*, 216 N.J. 433 (2014).
3. Motorcycle License Plate Display – Consideration of a Draft Tentative Report regarding motorcycle license plate display pursuant to N.J.S. 39:3-33 in order to clarify the statute's provisions and provide clearer guidance to traffic enforcement personnel.
4. Anti-Eviction Act – Consideration of a Memorandum providing legislative history and background information regarding use of the term "building" in N.J.S. 2A:18-61.1(1)(3) of the N.J. Anti-Eviction Act, which the N.J. Supreme Court considered in *Cashin v. Bello*, 223 N.J. 328 (2015).
5. State v. Rose – Consideration of a Memorandum seeking authorization to undertake a project to determine whether modification of the aggravated assault statute, N.J.S.A. 2C:11-4(a) in order to more clearly distinguish between aggravated and reckless manslaughter is appropriate.
6. Magic Petroleum v. Exxon Mobil Corp – Consideration of a Memorandum proposing a project to determine whether modification of the New Jersey Spill Compensation and Control Act (Spill Act) to reflect the determination of the Court in *Magic Petroleum* is appropriate.
