META pertains to the conversion of one kind of business organization to another, or the merger of two or more business organizations into one organization (it addresses “one-step intra- and inter-entity organic reorganizations such as mergers, conversions, interest exchanges and domestications”). Goodwin*) – Consideration of a Memorandum proposing a project to clarify the meaning of the term “material” in the insurance fraud statute (N.J.S. 2C:21-4.6) pursuant to the determination of the New Jersey Supreme Court in *State v.
